

## What is Bidnet Direct?

State and local government agencies throughout Colorado and Wyoming, like the [Town of Ault](#), utilize Bidnet Direct for distribution of solicitations - including documents and addendum, vendor management and award management. Many participating agencies also utilize the electronic bid submission option for vendors to submit responses directly online through the platform. In addition, our content team of researchers visits thousands of agency websites, newspapers, and other locations to aggregate open solicitations from non-participating agencies to alert registered vendors of matching opportunities.

## How do I register on Bidnet Direct to receive Town of Ault's business opportunities?

Registration on Bidnet Direct is done online. To receive notifications matching the Town of Ault's business opportunities, simply register [here](#).

## What are the registration options?

There are 3 types of registration options.

When you register, you are registering for access to not only the [Town of Ault's](#) open solicitations, but also solicitations from other participating agencies throughout Colorado and Wyoming.

Limited registration will send you automatic notifications of matching solicitations from the Town of Ault and other member agencies in the Rocky Mountain E-Purchasing System and allows you to access documents and respond to electronic bids.

For maximum bid opportunities and features Statewide or Federal bids allows you to receive matching email notifications from all Member Agencies across Colorado and Wyoming, State & Local, and/or Federal bids.

## **What information do I need to register on Bidnet Direct?**

Basic registration requires key contact information for your company's main user, such as company name, address, and phone number. Once you have completed the basic registration, you will receive an email to verify your account information. After your account is verified, you will be prompted to complete additional information, including NIGP Category code selections and any applicable Disadvantage Business Enterprise (DBE) or Small Business (SB) certification information. ## **Will I be able to download documents?**

Yes, all registered vendors can download documents from the [Town of Ault](#) along with other participating agencies documents attached to matching solicitations.
